ORDER

For consideration are the REQUEST FOR EXTENSION OF TIME TO FILE THE VERIFIED OPPOSITION and MANIFESTATION WITH MOTION TO SUSPEND PROCEEDINGS filed by Opposer on 20 July 2010 and 27 July 2010 respectively.

Record shows that this Bureau issued Order No. 2010- 680 giving the Opposer a final extension of thirty (30) days, from June 20, 2010 or until July 20, 2010, within which to file the Verified Notice of Opposition.

Since the 120-day period within which to file the verified notice of opposition has already lapsed on July 20, 2010, this Bureau cannot act on the request of the Opposer for another Extension Time to File Verified Opposition and Manifestation with Motion to Suspend Proceedings.

Section 4. (a) *Extension of period for filing the verified opposition* - For good cause shown and upon payment of the required surcharge, the time for filing the verified opposition may be extended for an additional one (1) month by the Director upon the written request of the opposer. Whenever an extension is granted, the Director shall cause the applicant to be notified thereof. The petition for extension shall be filed in triplicate. However, in no case shall the period within which to file the verified opposition exceed four (4) months from the date of release of the IPO Gazette publishing the mark being opposed. If the last day of filing of the notice of opposition or verified opposition falls on a Saturday, Sunday, holiday, non-working holiday as may be declared by the President of the Philippines or on a day when the Office or the Bureau is closed for business as may be declared by the Director General, the same shall be moved to the immediately following working day. x x x.

WHEREFORE, premises considered, the Motion for Extension of Time to File a Verified Notice of Opposition and Manifestation with Motion to Suspend Proceedings are hereby DENIED.

Let the filewrapper of Trademark Application Serial No. 4-2009-990085 be returned to the Bureau of Trademarks (BOT) for appropriate action in accordance with this Order.

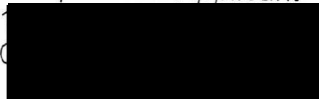
